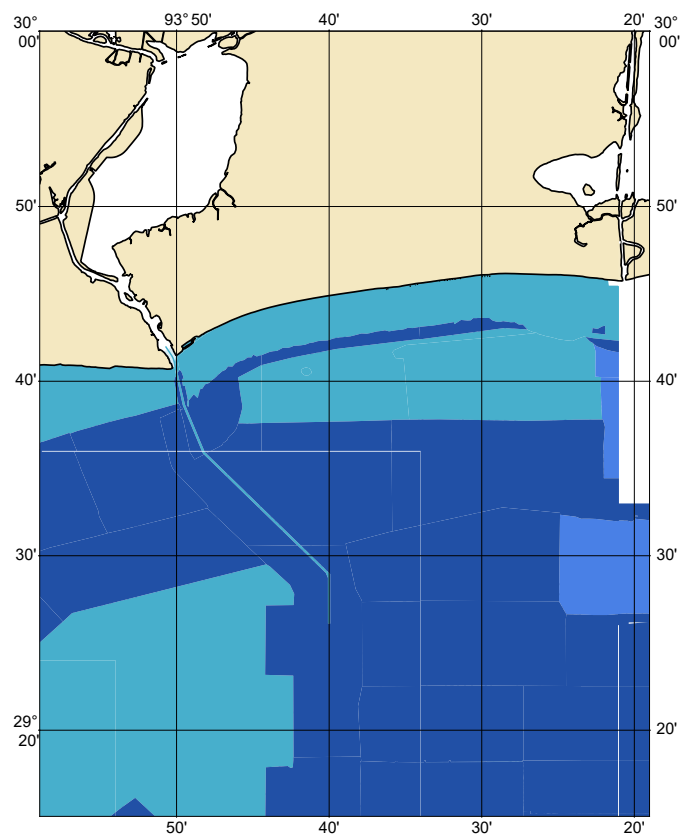


Zone of Confidence (ZOC) Diagram

In the area seaward of the COLREGS demarcation lines, vessels are governed by COLREGS: International Regulations for Preventing Collisions at Sea, 1972. The COLREGS demarcation line is defined in COLREGS 33 CFR 80.835g.

## HURRICANES AND TROPICAL STORMS

Hurricanes, tropical storms and other major storms may cause considerable damage to marine structures, aids to navigation and moored vessels, resulting in submerged debris in unknown locations. Charted soundings, channel depths and shoreline may not reflect actual conditions following these storms. Fixed aids to navigation may have been damaged or destroyed. Buoys may have been moved from their charted positions, damaged, sunk, extinguished or otherwise made inoperative. Mariners should not rely upon the position or operation of an aid to navigation. Wrecks and submerged obstructions may have been displaced from charted locations. Pipelines may have become uncovered or moved. Mariners are urged to exercise extreme caution and are requested to report aids to navigation discrepancies and hazards to navigation to the nearest United States Coast Guard unit.

## COLREGS DEMARCATION LINE

The Inland Navigational Rules Act of 1980 is in effect for vessels transiting this area. The seaward boundaries of this area are the COLREGS demarcation lines. ## MINERAL DEVELOPMENT STRUCTURES

Obstruction lights and sound (fog) signals are required for fixed mineral development structures, subject to approval by the District Commander, U.S. Coast Guard (33 CFR 67).

## VESSEL TRAFFIC SERVICES (VTS)

The U.S. Coast Guard operates a mandatory Vessel Traffic Services (VTS) on the Sabine-Neches Waterway and offshore approaches. Vessel operating procedures, mandatory participation boundaries, and designated radiotelephone frequencies are published in 33 CFR 161, the U.S. Coast Pilot, and the VTS Port Arthur User Manual. Mariners should consult these sources for applicable rules and reporting requirements. 'Port Arthur Traffic' is a full service VTS, providing a continuous Information Service; Traffic Organization Services and Navigational Assistance Services as required.

## INTRACOASTAL WATERWAY AIDS

The U.S. Aids to Navigation System is designed for use with nautical charts, and the exact meaning of an aid to navigation may not be clear unless the appropriate chart is consulted. Aids to navigation marking the Intracoastal Waterway exhibit unique yellow symbols to distinguish them from aids marking other waterways. When following the Intracoastal Waterway westward from Carrabelle, FL to Brownsville, TX, aids with yellow triangles should be kept on the starboard side of the vessel and aids with yellow squares should be kept on the port side of the vessel. A horizontal yellow band provides no lateral information, but simply identifies aids to navigation as marking the Intracoastal Waterway.

Improved channels are subject to shoaling, particularly at the edges.

## SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. Not all submarine pipelines and submarine cables are required to be buried, and those that were originally buried may have become exposed. Mariners should use extreme caution when operating vessels in depths of water comparable to their draft in areas where pipelines and cables may exist, and when anchoring, dragging or trawling.

Covered wells may be marked by lighted or unlighted buoys.

Temporary changes or defects in aids to navigation are not indicated on this chart. See Local Notice to Mariners.

During some winter months or when endangered by ice, certain aids to navigation are replaced by other types or removed. For details, see U.S. Coast Guard Light List.

Radio direction-finder bearings to commercial broadcasting stations are subject to error and should be used with caution.

## GAS AND OIL WELL STRUCTURES

Numerous uncharted gas and oil well structures, pipes, piles, and stakes exist within the obstruction area. Uncharted structures may exist outside the obstruction area.

## CAUTION

Small craft operators in Calcasieu River are warned to beware of severe water turbulence caused by large vessels traversing narrow waterways.

Charted piles in Calcasieu Lake may be submerged.

## NOTE

It is recommended that vessels transiting the Intracoastal Waterway make a SÉCURITÉ call on VHF-FM Channel 13 prior to entering the Sabine-Neches Canal at the Neches River, Sabine River, and Port Arthur Ship Canal.

## GAS AND OIL WELL STRUCTURES

Uncharted platforms, gas and oil well structures, pipes, piles, and stakes exist in the Calcasieu Lake. Uncharted structures may exist outside the obstruction area.

## STRONG CURRENTS

Strong cross-currents may exist across the entrance to the Calcasieu Jetties.

A small inlet connecting Calcasieu Lake and the canal was reported open in 2004.
