

# CAUTION SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. #### AIDS TO NAVIGATION

<CLR red="0" green=" 0" blue=" 0"> Aids to navigation in the Cayuga & Seneca Canal are the responsibility of the New York State Thruway Authority. All lighted aids, stationary and floating, unless otherwise indicated display a 1 second flash every 4 seconds.</CLR>

# CAUTION POTABLE WATER INTAKE

Vessels operating in fresh water lakes or rivers shall not discharge sewage, or ballast, or bilge water within such areas adjacent to domestic water intakes as are designated by the Commissioner of Food and Drugs (21 CFR 1250.93). Consult U.S. Coast Pilot 6 for important supplemental information.

## CAUTION

Due to periodic high water conditions, in the Great Lakes, some features charted as visible at Low Water Datum may be submerged, particularly in the near shore areas. Mariners should proceed with caution.

# NOTE Z NO-DISCHARGE ZONE, 40 CFR 140

Under the Clean Water Act, Section 312, all vessels operating within a No-Discharge Zone (NDZ) are prohibited completely from discharging any sewage, treated or untreated, into the waters. vessel sewage Commercial shall include graywater. All vessels with an installed marine sanitation device (MSD) that are navigating, moored, anchored, or docked within a NDZ must have the MSD disabled to prevent the overboard discharge of sewage (treated or untreated) or install a holding tank Regulations for the NDZ are contained in the U.S. Coast Pilot. information Additional the regulations and concerning requirements may be obtained from the Environmental Protection Agency (EPA) website: https://www.epa.gov/vesselsmarinas-and-ports .

#### SENECA CANAL

Shoaling to 0.9 meters/3 feet has been reported for the entire width of the channel from Frog Hollow Marina to Montour Falls.
